APPROVING MAP OF EAST MISSION VALLEY INDUSTRIAL CENTER

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by WILLIAM B. RICK, Registered Civil Engineer, entitled "EAST MISSION VALLEY INDUSTRIAL CENTER Being a subdivision of portions of Lots 1 and 2 in Block 50 and portions of Lot 1 and 2 in Block 51 of Grantville and outlots, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 776, filed in the office of the County Recorder of San Diego County, February 16, 1894.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Mission Gorge Place for public purposes; and said street is hereby declared to be a public street and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.


