APPROVING MAP OF VILLA MARTINIQUE NORTH
UNIT NO. 5 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Civil Engineer, entitled "VILLA MARTINIQUE NORTH UNIT NO. 5 Being a subdivision of Portions of Lots 1, 2, 15, 16 and 17 of Block 16, of Resubdivision of Lots 14, 16, 18, 19 and 20 of Rosedale Tract, according to Map thereof No. 857, filed in the office of the County Recorder of San Diego County on April 3, 1899 together with a portion of an unnamed street closed and vacated to public use and together with a portion of Clairemont Mesa Boulevard as dedicated to public use all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public, the following: Marigot Place and Lamentin Court for public purposes; and said streets are hereby declared to be public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in paragraphs 1, 2 and 3 of the Owner's certificate, as shown on this map and subject to the conditions set forth thereon.
