WHEREAS, the State of California has offered two excess parcels of land comprising approximately 22.12 acres to the City for \$56,600.00 to be used for public purposes; and


WHEREAS, these parcels, lying within the City's proposed Kensington Open Space Park Reserve, are being held for the City's adoption of a resolution authorizing offers to purchase prior to April 22, 1976; and

WHEREAS, funds for this acquisition will not be available until after July 1, 1976 and the State has agreed to hold the parcels until the funds can be paid, provided the City passes a resolution authorizing the offers to purchase prior to April 22, 1976; and

WHEREAS, the Fair Market Value of \$56,600.00 for the 22.12 acres was based upon a State staff appraisal and was approved by City staff; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be and he is hereby authorized to execute the Offers To Purchase two parcels of surplus land from the State of California, to be used for public purposes, forms of which offers are on file in the office of the City Clerk as Document Nos. 755053 and 755054.
