RESOLUTION NO. 215812

WHEREAS, the Legislature enacted Senate Bill 2268 in the 1974 Session creating a pedestrian-bicycle demonstration project across the San Diego-Coronado Bay Bridge; and

WHEREAS, since the beginning of bicycle shuttle service across the bridge in April 1975, up to 15,000 bicycles have been transported; and

WHEREAS, the continued operation of a bicycle-pedestrian shuttle across the bridge affords the citizens of San Diego a major means of nonmotorized travel; and

WHEREAS, the Legislature has received a report from the California Department of Transportation entitled "Pedestrian and Bicycle Access to State Owned Toll Bridges," which supports continued nonmotorized access to the Bay Bridge; and

WHEREAS, the funds allocated to operate this service are terminating, thus eliminating a vital link in the proposed Bay Route Bikeway system; and

WHEREAS, the San Diego Transit Corporation operates bus service across the San Diego-Coronado Bay Bridge; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That this Council hereby requests the San Diego Transit Corporation to consider and evaluate the feasibility of


