

RESOLUTION NO. 215844

WHEREAS, Section 102.0809 of the San Diego Municipal Code requires that the MAP OF POPULATION-BASED PARK SERVICE DISTRICTS OF THE CITY OF SAN DIEGO be presented at least annually to the City Council for review and ratification; and

WHEREAS, the 1974-75 map adopted by Resolution No. 212359 is now due for review and ratification; and

WHEREAS, the map presently being submitted for adoption is a refinement of the said 1974-75 map providing for some minor adjustments in boundaries among some previously established districts in Rancho Penasquitos, said adjustments to reflect a lower population density in these areas than that projected when the park service district boundaries were originally drawn; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That this Council hereby adopts the 1976 MAP OF POPULATION-BASED PARK SERVICE DISTRICTS OF THE CITY OF SAN DIEGO, a copy of which is on file in the office of the City Clerk as Document No. 755109.
