BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of up to \$43,550 is hereby authorized out of Community Development Block Grant Fund 290 of The City of San Diego, solely and exclusively, for the continued financing of the SOCIAL PLANNING UNIT of the Human Resources Department in the amount of \$21,700 and for the COMMUNITY CENTER FOR STUDENT DEVELOPMENT in the amount of \$21,850, a continuing Model Cities Program, for a two-month period beginning May 1, 1976 and extending up to June 30, 1976, or
