

RESOLUTION NO. 215845 APR 28 1976

WHEREAS, by Resolution No. 215416 on February 24, 1976, the City Council authorized the expenditure of \$46,200 in Community Development Block Grant funds for the purpose of continuing the operation by the Human Resources Department of the Social Planning Unit and the Community Center for Student Development for a two-month period starting March 1, 1976, or until the City Council grants final approval of necessary program budgets, whichever occurs first; and

WHEREAS, the Second Year Community Development Block Grant Program Budget is still under review by the City Council and it is necessary to provide additional interim funding to prevent a lapse in operations of said programs; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the expenditure of up to \$43,550 is hereby authorized out of Community Development Block Grant Fund 290 of The City of San Diego, solely and exclusively, for the continued financing of the SOCIAL PLANNING UNIT of the Human Resources Department in the amount of \$21,700 and for the COMMUNITY CENTER FOR STUDENT DEVELOPMENT in the amount of \$21,850, a continuing Model Cities Program, for a two-month period beginning May 1, 1976 and extending up to June 30, 1976, or

Said programs shall be operated in accordance with the existing program format and in compliance with all federal guidelines and regulations for the expenditure of said funds.
