1. That the bid of \$586,541.00 by Steve P. Rados, Inc., a corporation, for the PACIFIC HIGHWAY SEWER, ALTERNATIVE A - SLIP LINING in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 754366.
2. That the expenditure of \$685,000.00 is hereby authorized out of the Sewer Revenue Fund (Fund 506) of the City of San Diego solely and exclusively for the purpose of providing funds for PACIFIC HIGHWAY SEWER, ALTERNATIVE A - SLIP LINING in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$1,011,000.00 from CIP No. 43-028 (6) to the Sewer Revenue Fund (Fund 506) Unallocated Reserve.
