

RESOLUTION NO. 215858 APR 28 1976

WHEREAS, The City of San Diego, California has entered into a contract with the U.S. Department of Housing and Urban Development (HUD) to carry out, within The City of San Diego, a housing and community development program; and

WHEREAS, the City Council on November 26, 1974 by Resolution No. 212090 allocated \$200,000 for commercial development from The City of San Diego's First Block Grant Application; and

WHEREAS, the successful implementation of the Market Street Block Grant commercial improvement project requires the use of Block Grant funds in the estimated amount of \$78,135.00; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the scope of services, work program and budget for the Market Street Block Grant Commercial Improvement Project as set forth in the document on file in the office of the City Clerk as Document No. 755100 be and the same are hereby approved.

2. That the City Manager or his designee is hereby authorized to expend the sum of \$78,135 from Block Grant Fund 2910 for the purposes of implementing the Market Street Commercial Improvement Project.
