

RESOLUTION NO. 215861 APR 28 1976

WHEREAS, the Council of The City of San Diego adopted Resolution No. 213424 on May 29, 1975, approving the recommendation of the International Affairs Board to actively pursue and establish a Sister City relationship with the City of Tema, Ghana; and

WHEREAS, such efforts were successful in that the cities of San Diego, California and Tema, Ghana have reached a mutual agreement to establish a Sister City relationship under the auspices of the National Town Affiliation Association program; and

WHEREAS, this Sister City alliance will afford an excellent opportunity for understanding to grow between the people of our two cities; and

WHEREAS, through exchange visits by citizens of the two cities, the ties of friendship and mutual respect will be strengthened; and

WHEREAS, this alliance will surely enrich the lives of the citizens of these two cities; and

WHEREAS, a group of interested citizens is organizing to promote a consistent and continuing program of international municipal interchange which will be mutually beneficial to the good relations and understanding of the citizens of these two cities; NOW, THEREFORE,
