
BE IT RESOLVED, by the Council of The City of San Diego as follows:

R. 76 - 2276

1. That the bid of \$1,890.00 by Henry L. Foster, an individual dba H. L. Foster Construction Co. for the CONSTRUCTION OF SIDEWALK IN WASHINGTON PLACE, NORTH SIDE, ADJACENT TO MISSION HILLS PARK in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 754696.
