BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider, TIME DEVELOPMENT CO., a partnership, that said subdivider will comply with the Affirmative Fair Housing Plan as outlined in Document No. 753597, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of FIESTA TIME UNIT NO. 4.
