


RESOLUTION No. 215893Adopted on MAY 5 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered, for and on behalf of said City, to implement through the Transportation Department, the Public Facilities and Services Project, a Community Development Block Grant Program, for the purpose of providing street improvements, including sidewalks, curbs and gutters in the Balboa School and Educational Cultural Complex areas of the City of San Diego, pursuant to the terms and conditions set forth in the Project Budget, Estimated Monthly Expenditure Schedules, Scope of Services, and Project Work Program, on file in the office of the City Clerk as Document No. 755147.

BE IT FURTHER RESOLVED, that the period of performance for this project, unless otherwise altered, shall be for twenty-six months and shall extend from November 1, 1975 through December 31, 1977, and that an amount not to exceed \$430,468 in First Year Community Development Block Grant Fund 2910 be allocated for the above purposes.
