BACKGROUND

In administering City contracts, three types of bonds have been required. Section 94 of the Charter requires that each bidder furnish with his bid such security as shall be specified by Council and, when a contract exceeds \$25,000, that the contractor furnish a faithful performance bond in the amount specified by Council. The Charter further requires that all contracts require a retention of payments sufficient to ensure protection of the City against labor or material liens. While not required by the Charter, a payment bond for the full contract amount has been utilized to ensure this requirement as well as retaining between 5% and 10% of the earned contract payment.

PURPOSE

To establish a uniform policy for bond or security deposits for City contracts to protect the interest of the City and to enhance the ability of small businesses to compete for City contracts.

POLICY

It is the policy of the City of San Diego to adhere to the following bonding requirements for City contracts:

A. Bid Bond

- 1. Contracts under \$25,000 Waive the requirement for furnishing any bid security or deposit insuring execution of the contract.
- 2. Contracts over \$25,000 Require bid security, in approved form, in the amount of ten percent (10%) to accompany the bid when submitted.

B. Faithful Performance Bond

- 1. Contracts (under \$25,000) Require no bond.
- Contracts (over \$25,000) Require a bond in the amount of 100% of the contract price be supplied in the manner and form prescribed by the latest edition of the Standard Specifications for Public Works Construction, on file in the City Clerk's office.

C. Payment Bond

- 1. Contracts under \$10,000 Waive the bond requirement, in which case total payment under the contract is to be made 35 days after acceptance of the completed work. No interim or progress payments shall be made and there may be retained from the payment any amounts required to cover claims for labor and materials liens identified with the project. A contractor may, however, still elect to post a payment bond and receive normal progress payments.
- 2. Contracts between \$10,000 and \$25,000 Waive the bond requirement. When recommended by the City Manager, interim or progress payments may be made as the work progresses but with a minimum of 20 percent of earned payment retained to cover possible labor and materials liens. A contractor, however, may still elect to post a payment bond and receive normal progress payments.
- 3. Contracts over \$25,000 Require a bond in the amount of 100% of the contract price be supplied in the manner and form prescribed by the latest edition of the Standard Specifications for Public Works Construction, on file in the City Clerk's office. Retention shall be made on the contract payments in accordance with the provisions in the Standard Specifications for Public Works Construction.
