

RESOLUTION No. 215900Adopted on MAY 5 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with VTN CONSOLIDATED, INC., dba VTN SAN DIEGO, for engineering services in connection with design and construction of PICADOR BOULEVARD and SMYTHE AVENUE, from Beyer Boulevard to Del Sol Boulevard, and BEYER BOULEVARD, a distance of approximately 640 feet, in the City of San Diego, under the terms and conditions set forth in the form of agreement on file in the office of the City Clerk as Document No. 755187.

BE IT FURTHER RESOLVED, that the expenditure of \$9,000 and \$25,200 is hereby authorized out of Gas Tax Fund 220 (CIP 52-189.1(6)) and Gas Tax Fund Reserve 220 (CIP 90-220(6)), respectively, of The City of San Diego, solely and exclusively for the purpose of providing funds for the above-referenced services and related costs, supplementing Resolution No. 209640 in these amounts.
