


RESOLUTION No. 215905Adopted on MAY 5 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of UNITED STATES CAPITAL CORPORATION, a California corporation, executed in favor of The City of San Diego, bearing date of February 10, 1976, conveying to said City an easement for a right of way for a public street and incidents thereto, through, over, under, upon, along and across a portion of Section 30, Township 14 South, Range 2 West, San Bernardino Meridian, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 3 is hereby dedicated as and for a public street and the same is hereby named BLACK MOUNTAIN ROAD; and the land therein conveyed as Parcel 6 is hereby dedicated as and for a public street and the same is hereby named CAPRICORN WAY.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
