That Change Order No. 2, dated November 25, 1975, heretofore filed with the City Clerk of said City as Document No. 755188, issued in connection with the contract between The City of San Diego and Griffith Company for the improvement of CAMINO RUIZ, BLACK MOUNTAIN ROAD AND MIRA MESA BOULEVARD, said contract having been filed in the office of the City Clerk as Document No. 750823, be and the same is hereby approved; and the change therein set forth, amounting to a net decrease in the contract price of \$28,923.35, be and the same is hereby approved.

BE IT FURTHER RESOLVED, that the expenditure of \$78,190.00 is hereby authorized out of Gas Tax Fund Reserve 220 of The City of San Diego, solely and exclusively, for the City's contribution and related costs for the above project, supplementing Resolution No. 212748 in this amount.
