WHEREAS, an increase in construction activity during the past six months coupled with plan check staff vacancies has resulted in the development of an excessive backlog and delay in processing plans through the structural plan check section of the Building Inspection Department; and

WHEREAS, certain private structural engineering firms have the capability of performing structural plan checking services and are willing to provide such services on a contract basis; and

WHEREAS, in order to reduce the above-mentioned backlog and delay it is proposed that the City enter into contracts with seven of the above-said private structural engineering firms; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Auditor and Comptroller is hereby authorized to transfer \$15,000 from General Fund 100 (Unallocated Reserve 53.21) to the Building Inspection Department (1721) Nonpersonnel Expense Account for Fiscal Year 1976, solely and exclusively, for contract plan checking services.
