
Adopted on MAY 11 1976

That a representative of the City Attorney's Office, C. M. Fitzpatrick, Senior Chief Deputy, is hereby authorized to travel to Washington, D. C., May 12-14, 1976 for the purpose of assisting the San Diego Transit Corporation in negotiation and execution of an Urban Mass Transportation Act 13-C Agreement for the Santa Fe Depot acquisition, and to incur all necessary expenses.

BE IT FURTHER RESOLVED, that the expenditure of \$700 is hereby authorized from Unallocated Reserve General Fund 100 (53.31) for the sole and exclusive purpose of providing funds for lodging, travel and miscellaneous expenses.
