RESOLUTION OF THE COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, PROPOSING TO MAKE CHANGES IN THE DIAGRAM AND FIXING A TIME AND PLACE FOR HEARING PROTESTS TO THE CHANGES AND GIVING NOTICE THEREOF.

PARK DISTRICT NO. 16
(Hendrix Park)

WHEREAS, in proceedings under the San Diego Park District Procedural Ordinance of 1969 and, in particular, Division 8 of Article 1, Chapter VI of the San Diego Municipal Code, the Council adopted resolution of intention, Resolution No. 215196, ordering the Superintendent of Streets to prepare the Report required by said procedural ordinance and pursuant thereto the Superintendent of Streets prepared said Report, consisting of plans and specifications describing the proposed acquisitions and improvements, an estimate of the costs and expenses of said acquisitions and improvements, a diagram showing the assessment district and a proposed assessment of the costs and expenses of the proposed acquisitions and improvements; and

WHEREAS, the Council by Resolution No. 215197 approved said Report, as filed, and appointed a time and place of hearing thereon and also for a public hearing on the question of whether public convenience and necessity require

such acquisitions and improvements and whether the Special Assessment Investigation, Limitation and Majority Protest Act of 1931 and the debt limitation and majority protest provisions thereof shall apply; and

WHEREAS, notices of the hearing were duly published, posted, and mailed, the mailed notices to property owners correctly setting forth the numbers of the individual assessment parcels and the amount proposed to be assessed upon each such parcel, and the hearing was held on March 10, 1976, at the time and place fixed; and

WHEREAS, on March 10, 1976 following the hearing, the Council adopted Resolution No. 215508, ordering reductions in the amounts of two assessments, and Resolution No. 215509 ordering the project and confirming the diagram and changed assessment; and

WHEREAS, after the hearing, notices of recordation of the assessment were duly published and mailed, the mailed notices to property owners correctly setting forth the numbers of the individual assessment parcels and the amount assessed upon each such parcel; and

WHEREAS, after the mailing of the notices of recordation, the Superintendent of Streets has submitted to the Council a Supplemental Report stating that the confirmed assessment sets forth correct numbers of the individual assessment parcels and the amount assessed upon each such parcel and further stating that, by inadvertence, the diagram, as submitted to and confirmed by the Council, shows incorrect numbers for some of the individual assessment parcels, that one assessment parcel is insufficiently dimensioned, and recommends that the Council undertake change proceedings to correct such numbers so that they will be in accordance with the numbers set forth in the assessment and to dimension one parcel; and

WHEREAS, the Supplemental Report contains proposed revised Sheet Numbers 16, 17, 18, and 19 of the diagram indicating the old incorrect parcel numbers and the correct new parcel numbers and also contains a "Schedule of Changes," setting forth the old and new numbers; and

WHEREAS, the Council is of the opinion that the recommended corrections to the diagram should be made, NOW, THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

Any and all persons having any protest or objection to said changes may appear before the Council at said hearing and show cause why said proposed acquisitions and improvements should not be carried out.


