That 55TH STREET, approximately 700 feet southerly of Orange Avenue, be and the same is hereby officially renamed COLTS' WAY, as more particularly shown and described in Drawing No. 13698-B, on file in the office of the City Clerk as Document No. 755244 which shall govern as to all details therein.
