

RESOLUTION No. 215948Adopted on MAY 12 1976


BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of PACIFIC BAY DEVELOPMENT CORPORATION, a California corporation, GILBERT DREYFUSS and LAWRENCE HERMAN, executed in favor of the City of San Diego, bearing date of March 23, 1976, conveying to said City portions of Lots 17 and 18, Halecrest Heights Unit No. 1, according to Map thereof No. 4747 together with a portion of Lot 12, Rancho Mission of San Diego, according to Partition Map thereof made in the action entitled "Commercial Bank of San Diego vs. Juan M. Luco, et al" as more particularly described in said deed, be and the same is hereby approved.

That the expenditure of \$70,000 from Capital Outlay Fund 245 and \$20,920 from Unallocated Reserve 90-245 Fund, for acquisition of the above described property is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
