

RESOLUTION No. 215955


Adopted on MAY 18 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That a portion of Lot 78 of Rancho Mission of San Diego, according to Partition Map of said Rancho, made in the action entitled "Juan M. Luco, et al. vs. The Commercial Bank of San Diego," and all that portion of Lot 8 of The Highlands, according to Map thereof No. 248, together with the unnamed street (now vacated to public use) adjoining said Lot 8 on the north, as described in that certain Offer to Dedicate executed by the San Diego Gas & Electric Company, a corporation, filed in the Office of the San Diego County Recorder April 4, 1974, as File/Page No. 74-085312, and as more particularly described in the legal description attached hereto and incorporated herein, be and the same is hereby accepted, set aside and dedicated as and for a public street and the same is hereby named COMPLEX STREET.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to file a certified copy of this resolution in the Office of the San Diego County Recorder.

LEGAL DESCRIPTION

COMPLEX STREET

All that portion of Lot 78 of Rancho Mission of San Diego, according to Partition Map of said Rancho, made in the action entitled "Juan M. Luco, et. al. vs. The Commercial Bank of San Diego," in Superior Court Case No. 348, filed in the Office of the County Clerk of said County of San Diego, and all that portion of Lot 8 of the Highlands, according to Map thereof No. 248, filed in the Office of the County Recorder of said County March 6, 1887, together with the unnamed street (now vacated to public use) adjoining said Lot 8 on the north, as described in that certain OFFER TO DEDICATE executed by San Diego Gas & Electric Company, a corporation, filed in the Office of said Recorder April 4, 1974 as File/Page No. 74-085312.

EXCEPTING THEREFROM all that portion described as follows: Beginning at the Southeast corner of that land described in said OFFER TO DEDICATE; thence North $00^{\circ}04'37''$ West along the Westerly line of said land, a distance of 138.12 feet to a point on a tangent curve, concave Northwesterly and having a radius of 179.82 feet; thence Southwesterly along the arc of said curve through a central angle of $28^{\circ}29'11''$, a distance of 89.40 feet to a point of reverse curvature concave Southeasterly, having a radius of 109.58 feet; a radial bears North $61^{\circ}35'26''$ West to said point; thence Southerly along the arc of said curve through a central angle of $28^{\circ}31'58''$, a distance of 54.57 feet to a point on the Northerly line of Clairemont Industrial Park Unit No. 1, according to Map thereof No. 6317 on file in the Office of the San Diego County Recorder; thence North $89^{\circ}55'56''$ East along said Northerly line, a distance of 35.04 feet returning to the Point of Beginning.
