as follows:


That Council Policy 600-10, Adequacy of Public Services
In Connection With Development Proposals, dated May 12, 1970
is hereby modified by addition of the following paragraph:

Because of the inter-relationship between
development in the I-15 Corridor communities of
Mira Mesa, Scripps Miramar, Lago Dorado, Chicarita
Creek, Carmel Mountain East, Rancho Penasquitos and
Rancho Bernardo, and the need for adequate trans-
portation and circulation facilities to serve these
communities, a statement of the highway and major
street improvements needed in connection with
future residential growth in this corridor has been
adopted by Council Resolution No. 215958
dated MAY 12 1976.

BE IT FURTHER RESOLVED, that the City Clerk is hereby
instructed to add the aforesaid to the Council Policy Manual.
