

RESOLUTION NO. 215965

WHEREAS, The City of San Diego has adopted an Affirmative Action Program (herein called "Program") designed to increase the percentage of minority and female citizens employed by The City of San Diego; and

WHEREAS, the City, in cooperation with the Law Enforcement Assistance Administration (herein called "LEAA") has agreed that the Program goals should be vigorously pursued for the City and in particular, the San Diego Police Department; and

WHEREAS, LEAA has reviewed the Equal Employment Opportunity Program (EEOP) for the Police Department which closely parallels City's Program in goals and timetables; and

WHEREAS, LEAA indicated some concern in regard to the timetable compliance under the Program and EEOP and has conveyed such concern to the City; and

WHEREAS, City and LEAA desire to reconcile such concern via several agreed upon courses of action to be taken by City, said courses of action contained in a Voluntary Compliance Agreement; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager and Personnel Director be and they are hereby fully authorized and empowered to execute, for and on behalf of The City of San Diego, an agreement with the Law Enforcement Assistance Administration relating to Police Department testing and training standards, pursuant to the terms
