2. That the expenditure of \$48,000.00 is hereby authorized out of the Capital Outlay Fund (Fund 245) of the City of San Diego solely and exclusively for the purpose of providing funds for CONSTRUCTION OF VILLA MONTEZUMA - FOUNDATION RECONSTRUCTION in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$12,000.00 from CIP No. 23-925 to the Capital Outlay Fund (Fund 245) Reserve CIP No. 90-245.
