


RESOLUTION No. 215988Adopted on MAY 19 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of JEAN ANN KOHLER, executed in favor of The City of San Diego, bearing date of November 21, 1975, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 3, Block 11 of First Addition to South La Jolla, according to Map thereof No. 891 on file in the San Diego County Recorder's Office, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named DUNEMERE DRIVE.

That the City Clerk is hereby authorized and empowered to file said deed, after acceptance by the City Manager, and a certified copy of this resolution for record in the office of the County Recorder of San Diego County.
