BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the STATE OF CALIFORNIA, Department of Transportation, executed in favor of The City of San Diego, conveying to said City an easement for public road purposes in and to those portions of Lots 112, 113 and 114 of Sunshine Gardens, according to Map No. 1804, filed in the office of the San Diego County Recorder, August 27, 1924, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the expenditure of \$6,000.00 from Gas Tax Fund 220 for acquisition of the above described property and related parcels is hereby authorized and approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
