


**RESOLUTION No. 215991**Adopted on MAY 19 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the STATE OF CALIFORNIA, Department of Transportation, executed in favor of The City of San Diego, conveying to said City an easement for public road purposes in and to those portions of Lots 25, 26 and 53 through 57 of Lemon Garden Acres, according to Map thereof No. 1390, filed in the office of the Recorder of San Diego County, December 20, 1911, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed as Parcel 1 is hereby dedicated as and for a public street and the same is hereby named 47TH STREET.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
