


RESOLUTION No. 215992Adopted on MAY 19 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of the STATE OF CALIFORNIA, Department of Transportation, executed in favor of The City of San Diego, conveying to said City an easement for drainage purposes and appurtenances thereto, over, under and across those portions of Lots 5 and 12 of Lemon Garden Acres, according to Map No. 1390, filed in the Office of the Recorder of San Diego County, December 20, 1911, as more particularly described in said deed, be and the same is hereby approved.

That the City Clerk is hereby authorized and directed to transmit said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
