WHEREAS, on July 24, 1975 and on August 19, 1975, the City Council of The City of San Diego (Resolution No. 213869) and the County of San Diego, respectively, approved a joint City-County resolution expressing the mutual intent of the City, County, and Human Care Services staffs to work together to avoid duplication of effort and to foster a free flow of information in the area of human care needs; and

WHEREAS, because senior citizens have important needs which must be met by selected senior citizen programs and services within the region of the City and County of San Diego, it is important for the City and County to establish guidelines in the form of a Memorandum of Understanding for mutual cooperation in order to maximize the effectiveness of these programs; and

WHEREAS, a Memorandum of Understanding has been prepared which contains the guidelines to be used in these cooperative efforts between the City and County of San Diego, and which has been approved in general concept by the San Diego County Board of Supervisors; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a Memorandum of Understanding with the County of San Diego for the purpose of implementing guidelines for the cooperative


