VACATION OF OLYMPIC AVENUE WESTERLY OF CRAWFORD STREET TO THE SOUTHERLY EXTENSION OF THE WESTERLY LOT LINE OF LOT 24, BLOCK 20; ALLEY IN BLOCK 20, EASTERLY OF THE SOUTHERLY PROLONGATION OF THE WESTERLY LINE OF LOT 14; AND THE WESTERLY EIGHT FEET OF CRAWFORD STREET BETWEEN ZION AVENUE AND THE EASTERLY PROLONGATION OF THE SOUTHERLY LINE OF OLYMPIC AVENUE, ALL BEING IN GRANTVILLE AND OUTLOTS.

WHEREAS, it is proposed that OLYMPIC AVENUE westerly of Crawford Street to the southerly extension of the westerly lot line of Lot 24, Block 20; ALLEY in Block 20 easterly of the southerly prolongation of the westerly line of Lot 14; and the westerly eight feet of CRAW-FORD STREET between Zion Avenue and the easterly prolongation of the southerly line of Olympic Avenue, all being in Grantville and Outlots, be vacated; and

WHEREAS, there is no present or prospective use for the streets, either for the public street system for which the rights-of-way were originally acquired or for any other public use of a like nature that can be anticipated; and

WHEREAS, the vacation or abandonment is not inconsistent with the General Plan or an approved Community Plan; and

WHEREAS, the public street system for which the rights-of-way were originally acquired will not be detrimentally affected by this vacation; and

WHEREAS, the public will benefit from the vacation through improved utilization of land; NOW, THEREFORE,


