1. That the bid of \$10,794.00 by El Cajon Grading & Engineering Co., Inc., a corporation, for the CONSTRUCTION OF THE LA PINTURA DRIVE STORM DRAIN in the City of San Diego, California is hereby accepted; and that the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 754835.
2. The expenditure of \$17,400.00 is hereby authorized out of the Storm Drain Bond Funds (Fund 727) of the City of San Diego solely and exclusively for the purpose of providing funds for the CONSTRUCTION OF LA PINTURA DRIVE STORM DRAIN in the City of San Diego, and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$16,820.00 from CIP No. 11-143 (6) to CIP No. 90-727, Flood Control and Storm Drain Bond Fund Reserve.
