APPROVING MAP OF PENASQUITOS SCENE SUBDIVISION AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by RONALD D. HOGAN, a Registered Civil Engineer, entitled
"PENASQUITOS SCENE Being a subdivision of Lot 3 of Penasquitos
School Site, in the City of San Diego, County of San Diego,
State of California, according to Map thereof No. 7582 filed
in the Office of the County Recorder of San Diego on March 19,
1973 together with a portion of Carmel Mountain Road as dedicated
to public use.", is made in the manner and form prescribed by
law and conforms to the surrounding surveys; that said map and
the subdivision of land shown thereon is hereby approved and
accepted; and said Council hereby accepts on behalf of the
public, the following: Paseo Aldabra and Aldabra Court for
public purposes; and said streets are hereby declared to be
public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts
on behalf of The City of San Diego, a municipal corporation,
any and all abutters' rights of access in and to Carmel
Mountain Road, adjacent and contiguous to Lots 1 through 5,
inclusive, Lots 38 through 45, inclusive, and a portion of
Lot 62; and abutters' rights of access in and to Aldabra
Court, adjacent and contiguous to Lot 46 and Lot 55, all
as shown on this map within this subdivision and subject to
the conditions set forth thereon.


