

RESOLUTION NO. 216034

MAY 26 1976

WHEREAS, Section 1930 of the Streets and Highways Code provides a procedure for the summary vacation of streets by City Council resolution where that portion to be vacated has been superseded by relocation; and

WHEREAS, that portion of LAS LOMAS STREET has been relocated by the approval on this date of the dedication of Sea Colony Court by the acceptance of the final map of the subdivision known as Sea Colony Point Loma; and


WHEREAS, those properties adjoining that portion of LAS LOMAS STREET to be vacated will continue to have access or will be accessible by the street which has been dedicated with the approval of the subdivision map known as Sea Colony Point Loma; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That LAS LOMAS STREET as more particularly shown on Drawing No. 13627-B on file in the office of the City Clerk as Document No. 755360, which said drawing is attached hereto and made a part hereof, be and the same is hereby ordered vacated.

2. That The City Clerk shall cause a certified copy of this resolution, attested by him under seal, to be recorded in the office of the County Recorder.
