

RESOLUTION No. 216036Adopted on MAY 26 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that deed of KAISER FOUNDATION HOSPITALS, a corporation, executed in favor of The City of San Diego, bearing date of March 18, 1976, conveying to said City the permanent easement and right of way for a public street and incidents thereto, over, under, upon, along and across a portion of Lot 20 in Block 20 of Grantville and Outlots, according to Map thereof No. 776, as more particularly described in said deed, be and the same is hereby approved; and the land therein conveyed is hereby dedicated as and for a public street and the same is hereby named CRAWFORD STREET.

That the City Clerk is hereby authorized and directed to deliver said deed, after acceptance by the City Manager, and a certified copy of this resolution to the Property Director for further handling.
