BE IT RESOLVED, by the Council of The City of San Diego as follows:

That Richard A. Burt be employed and appointed as special bond counsel in connection with the proceedings under the Municipal Improvement Act of 1913 for the improvement of PALM AVENUE from Interstate 5 to Hawaii Avenue, pursuant to the terms and conditions set forth in the letter dated March 3, 1976, on file in the office of the City Clerk as Document No. 755369.

BE IT FURTHER RESOLVED, that in the event the proposed proceedings described above fail to materialize or are abandoned prior to the issuance of bonds, the City shall be liable for payment for services and costs incurred in said employment in an amount not to exceed \$4,500 in accordance with the terms and conditions of said letter of March 3, 1976.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$4,500 from Gas Tax Fund 220 is hereby authorized, solely and exclusively, for payment of the above-stated services and costs in the event the proposed proceedings fail to materialize or are abandoned prior to the issuance of bonds.
