BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of said City, a Tideland Use and Occupancy Permit with the SAN DIEGO UNIFIED PORT DISTRICT, whereby City leases approximately 7,362 square feet of tideland area located in Block 21, New San Diego, for vehicle parking of the San Diego Police Department at a monthly rental of \$172.00 for a nine-month period beginning May 1, 1976, under the terms and conditions set forth in the form of permit on file in the office of the City Clerk as Document No. 755375.
