RESOLUTION DECLARING THE RESULTS OF THE SPECIAL
INFORMAL ELECTION HELD IN THE OCEAN BEACH PRECISE
PLANNING AREA OF THE CITY OF SAN DIEGO, TUESDAY,
MAY 4, 1976.

WHEREAS, Council Resolution No. 215348, adopted February 17, 1976, a copy of which is attached hereto, called for a special informal election for the purpose of electing candidates to serve on a new citizens' advisory planning committee to assist the City of San Diego in the implementation of the Ocean Beach Precise Plan primarily through the developing of a Planned District Ordinance for the area; and

WHEREAS, pursuant to said Resolution such an election was held Tuesday, May 4, 1976; and

WHEREAS, a copy of the certificate of the San Diego County Registrar of Voters canvassing the returns of the special informal election, including the absentee votes cast, has been received; and

WHEREAS, a canvass of this election has been completed and the results certified to the City Council; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, that the Council finds and determines, pursuant to the provisions of Resolution No. 215348, as follows:

1. The total number of votes, including absentee votes, received by each candidate to serve on a new citizens' advisory planning committee to assist the City of San Diego in the implementation of the Ocean Beach Precise Plan, primarily through the developing of a Planned District Ordinance for the area, are as recorded on the certificate of the Registrar of Voters as attached hereto and a part of this Resolution.


