WHEREAS, the City Council of the City of San Diego on July 3, 1975, adopted the Ocean Beach Precise Plan; and

WHEREAS, said plan is to be implemented by a committee elected by the citizens residing within the boundaries of the Ocean Beach Precise Plan area; and

WHEREAS, on May 4, 1976, under the direction of the Planning Director and the San Diego County Registrar of Voters, a community-wide special informal election was conducted within said area in compliance with the provisions contained in City Council Resolution No. 215348, resulting in the election of fourteen (14) candidates to serve as the citizens advisory planning committee to assist the City of San Diego in the implementation of the Ocean Beach Precise Plan and the developing of a Planned District Ordinance for the area; and

WHEREAS, by City Council Resolution No. 216062, the City Council has canvassed the results of said election as recorded on the certificate of the Registrar of Voters and declares the fourteen (14) persons, two (2) from each of seven (7) districts, receiving the highest number of votes to constitute the Ocean Beach Planning Committee;

NOW THEREFORE, BE IT RESOLVED, by the Council of the City of San Diego as follows:

The Ocean Beach Planning Committee be and is hereby authorized to represent the Precise Plan area and work with the City Manager's office and the Planning Department in the implementation of said Ocean Beach Precise Plan, primarily through advising on the development of a Planned District Ordinance consistent with community goals and obligations, and be responsible for its presentation as well as the coordination of community support for its adoption and effectuation;

AND BE IT FURTHER RESOLVED that the Ocean Beach Planning Committee shall be organized as provided in City Council Resolution No. 215348, to be supplemented by subsequent adoption of standard community planning committee bylaws as these are established by the City Council;

AND BE IT FURTHER RESOLVED that the Planning Department Program Budget shall provide for the preparation of a Planned District Ordinance to implement the adopted Ocean Beach Precise Plan upon which the Ocean Beach Planning Committee shall provide advice.
