

RESOLUTION No. 216064Adopted on JUN 2 1976

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Attorney and City Manager are hereby requested to provide a specific date, or a number of specific dates, if necessary, which would constitute a reasonable time after May 31, 1976, for the Scripps and Crescent Beach lessees to have removed all structures and reconstructed and restored the area to public beach conditions, as required by the lease.

BE IT FURTHER RESOLVED, that the City Attorney is hereby requested to advise the Council on what courses of action might be open to the City in the event lessees, or some of them, do not comply with the provisions of the lease, and at what point and under what conditions any existing structures may be considered to have come into City ownership.

BE IT FURTHER RESOLVED, that the City Manager is hereby directed to provide a schedule of events which management intends to implement with regard to Crescent Bay (Sail Bay) and its beaches.
