

RESOLUTION NO. 216071 JUN 2 1976APPROVING MAP OF VILLA MARTINIQUE NORTH UNIT
NO. 6 SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, Registered Civil Engineer, entitled "VILLA MARTINIQUE NORTH UNIT NO. 6 Being a subdivision of portion of Lot 15 of Rosedale Tract, according to Map thereof No. 825, filed in the office of the County Recorder of San Diego County on January 21, 1897; portions of Lots 15, 16 and 17 of Block 16 of resubdivision of Lots 14, 16, 18, 19 and 20 of Rosedale Tract, according to Map No. 857, filed in the office of the County Recorder of San Diego County on April 3, 1899 together with a portion of Clairemont Mesa Boulevard as dedicated to public use; all in the City of San Diego, County of San Diego, State of California.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved; and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, the easements listed in paragraphs 1, 2 and 3 of the Owner's certificate, as shown on this map and subject to the conditions set forth thereon.


