

WOLF, BENO HIRSCHBEIN and HELEN HIRSCHBEIN, for the installation and completion of certain public improvements in the subdivision to be known as MONTGOMERY INDUSTRIAL PARK UNIT NO. 1, under the terms and conditions set forth in the form of Amendment to Subdivision Improvement Agreement for Montgomery Industrial Park Unit No. 1 on file in the office of the City Clerk as Document No. 755399.

BE IT FURTHER RESOLVED, that Bond No. 13757, issued by the Fremont Indemnity Company in the amount of \$18,398, is hereby accepted as improvement security for the performance of the public improvements, and that Bond No. MNR 93 33 10, issued by the Insurance Company of North America, is hereby released.
