


RESOLUTION No. 216073Adopted on JUN 2 1976

That an easement for the purpose of a right of way for drainage purposes through, over, under, along and across a portion of Block 1 of Nettleship - Tye Tract No. 1, according to Map thereof No. 1931 filed in the office of the County Recorder of San Diego County, as more particularly described in the legal description attached hereto as Exhibit A, be and the same is hereby set aside for such public purposes.

LEGAL DESCRIPTION

All that portion of Block 1 of Nettleship - Tye Tract No. 1 according to Map thereof No. 1931 filed in the Office of the County Recorder of San Diego County being more particularly described as follows:

A strip of land 10.00 feet wide lying 5.00 feet on each side of the following described centerline:

Commencing at the Southwesterly corner of Lot 6 of said Block 1 being also a point on the Northerly line of Palisades Park as said park is located and established on the date of this document; thence North $75^{\circ}28'00''$ East along said Northerly line of Palisades Park being the Southerly line of said Lot 6 27.44 feet to the TRUE POINT OF BEGINNING; thence leaving said Northerly line of Palisades Park South $09^{\circ}32'11''$ West 69.58 feet to the beginning of a tangent 90.00 foot radius curve concave Northwesterly; thence Southwesterly along the arc of said curve through a central angle of $40^{\circ}56'45''$, a distance of 64.32 feet; thence tangent to said curve South $50^{\circ}28'56''$ West 54.48 feet to a point of terminus in the Westerly line of said Palisades Park.

The sidelines of the above described strip of land shall be prolonged or shortened to terminate Northerly in said Northerly line of Palisades Park and Westerly in said Westerly line of Palisades Park.
