

RESOLUTION NO. 216076 JUN 2 1976

WHEREAS, there were relinquished to The City of San Diego certain abutter's rights of access in and to Westover Place, affecting Parcel 1 of Parcel Map No. 4009; and

WHEREAS, the KFC NATIONAL MANAGEMENT COMPANY, the owner of the property, has requested that an exchange of abutter's rights be made to allow better utilization of the land; and

WHEREAS, it has been determined that the Transportation and Engineering Departments have no objection to the exchange of said abutter's rights of access; and

WHEREAS, the value of the property rights to be exchanged are equal, neither exceeding \$500 in value as determined by a staff appraisal; and

WHEREAS, this action is exempt from the provisions of the California Environmental Quality Act of 1970 under City guidelines for implementation of said Act, as amended; and

WHEREAS, it is in the public interest that said exchange be made, and the City Manager, pursuant to Section 22.0902.2 of the San Diego Municipal Code, has recommended it; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the Mayor and the City Clerk of said City be, and they are hereby authorized and empowered to execute, for and on behalf of, and as the act and deed of, The City of San Diego, a quitclaim deed, the form of which is on file in the office of the City Clerk

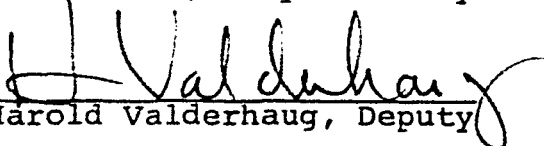
