

RESOLUTION NO. 216088 JUN 2 1976


WHEREAS, the City owns three single family residences in La Jolla which were acquired several years ago as a part of the Fay Avenue extension project and at the present time the houses are leased to tenants who are certified to the City by the SOFA Organization; and

WHEREAS, it is desirable that the three residences continue to be rented to low income families and in order for such families to be able to afford to live in said residences it is necessary and desirable that the rent be fixed at an amount which is less than the current fair market rental for the residences; and

WHEREAS, the fair market rental amounts for the three residences have been determined to be \$200, \$225 and \$250, respectively, and it is recommended that they be made available to low income families for \$90, \$100 and \$150, respectively; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager is hereby authorized to rent the residences at 7023 Fay Avenue, 6204 Beaumont, and 7127 Fay Avenue for a monthly rental of not less than \$90, \$100 and \$150, respectively, to low income families.
