BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, an Option to Lease Agreement with the YOUNG MEN'S CHRISTIAN ASSOCIATION OF SAN DIEGO AND SAN DIEGO COUNTY, a California non-profit corporation, for the purpose of construction, operation and maintenance of a YMCA Community Center, in a portion of Pueblo Lot 1101, appraised at \$419,000, under the terms and conditions set forth in the form of Option Agreement on file in the office of the City Clerk as Document No. 755438.

That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with the YOUNG MEN'S CHRISTIAN ASSOCIATION OF SAN DIEGO AND SAN DIEGO COUNTY, a California nonprofit corporation, after all option terms and conditions have been performed and the option has been exercised, which form of lease agreement is on file in the office of the City Clerk as Document No. 755439.
