

RESOLUTION NO. 216106 June 8, 1976RESOLUTION OF THE COUNCIL OF THE CITY  
OF SAN DIEGO, CALIFORNIA, ORDERING  
CHANGES IN THE DIAGRAM.

PARK DISTRICT NO. 16 (Hendrix Park)

WHEREAS, in proceedings under the San Diego Park District Procedural Ordinance of 1969 and, in particular, Division 8 of Article 1, Chapter VI of the San Diego Municipal Code, the Council adopted resolution of intention, Resolution No. 215196, ordering the Superintendent of Streets to prepare the Report required by said procedural ordinance and pursuant thereto the Superintendent of Streets prepared said Report, including a proposed diagram; and

WHEREAS, the Council by Resolution No. 215197 approved the Report, as filed, appointed a time and place of hearing thereon, notices of the hearing were duly published, posted, and mailed, and the hearing was held on March 10, 1976, at the time and place fixed; and

WHEREAS, on March 10, 1976 following the hearing, the Council adopted Resolution No. 215508, ordering reductions in the amounts of two assessments, and Resolution No. 215509 ordering the project and confirming the diagram and changed assessment; and

WHEREAS, on May 12, 1976, following the submission of a Supplemental Report by the Superintendent of Streets, the Council adopted Resolution No. 215936 proposing and declaring its intention to make the changes, as described in the resolution and the Supplemental Report, determining that the proposed changes will not increase or decrease the total amount of the assessment nor the amounts of any of the individual assessments shown in the assessment, and fixing a time and place of hearing on the proposed changes; and

WHEREAS, Resolution No. 215936 was duly published and the hearing on the proposed changes was duly held at the time and place fixed and all continuances, if any, were duly made and ordered; and

WHEREAS, at the hearing all persons desiring to be heard were fully heard and all oral and written protests, if any, were fully heard and this Council gave all persons present an opportunity to hear and be heard in respect to the proposed changes and the Supplemental Report; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

Section 1. Except to the extent of any additional changes ordered by the Council, each and all oral and written protests and objections, if any, made or filed in the matter of the proposed changes are hereby overruled and denied.

Section 2. Sheets Nos. 16, 17, 18 and 19 of the diagram are ordered to be changed, as described in Resolution No. 215936 and the Supplemental Report. Reference is hereby made to the resolution and the Supplemental Report for a full and complete description of the changes and for further particulars.

Section 3. The Superintendent of Streets is ordered to remove original Sheets Nos. 16, 17, 18 and 19 of the diagram on file in his office and to replace them with modified Sheets Nos. 16, 17, 18 and 19 which shall supersede the original sheets of the same numbers.

Section 4. The City Clerk is ordered to record a Supplemental Notice of Recordation with the County Recorder concerning the changes hereby ordered and, contemporaneously


