Said Council hereby finds that that certain map surveyed by GARY L. McCABE, a Registered Civil Engineer, entitled Being a subdivision of a portion of Pueblo "ABERNATHY SQUARE Lot 1233 of the Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, a copy of which said Map was filed in the Office of the County Recorder of San Diego County, November 14, 1921, and is known as Miscellaneous Map No. 36, together with a portion of Mt. Abernathy Avenue as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is approved and accepted; and said Council hereby accepts on behalf of the public, the following: Cannington Drive, Jamar Drive, Jamar Court, Lana Drive, Lana Lane, Kesling Street and a portion of Mt. The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated; and that those certain easements for drainage facilities as granted and shown on this map are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider DANA ASSOCIATES, a partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 751410, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of ABERNATHY SQUARE.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
