APPROVING MAP OF ABERNATHY SQUARE SUBDIVISION AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE OF
COMPLIANCE WITH THE AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed
by GARY L. McCABE, a Registered Civil Engineer, entitled
"ABERNATHY SQUARE Being a subdivision of a portion of Pueblo
Lot 1233 of the Pueblo Lands of San Diego, in the City of
San Diego, County of San Diego, State of California, according
to Map thereof made by James Pascoe in 1870, a copy of which
said Map was filed in the Office of the County Recorder of San
Diego County, November 14, 1921, and is known as Miscellaneous
Map No. 36, together with a portion of Mt. Abernathy Avenue
as dedicated to public use.", is made in the manner and form
prescribed by law and conforms to the surrounding surveys;
that said map and the subdivision of land shown thereon is
approved and accepted; and said Council hereby accepts on
behalf of the public, the following: Cannington Drive, Jamar
Drive, Jamar Court, Lana Drive, Lana Lane, Kesling Street
and a portion of Mt. Abernathy Avenue, for public purposes;
and said streets and portion of a street are hereby declared
to be public streets and portion of a public street and
dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts on
behalf of The City of San Diego, a municipal corporation, the


easements with the right of ingress and egress for the construction and maintenance of drainage facilities as granted and shown on said map and subject to the conditions set forth thereon.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said public streets and portion of a public street are accepted on behalf of the public as heretofore stated; and that those certain easements for drainage facilities as granted and shown on this map are accepted on behalf of The City of San Diego, a municipal corporation, as above stated.

BE IT FURTHER RESOLVED, that said Council hereby acknowledges receipt of assurance from the subdivider DANA ASSOCIATES, a partnership, that said subdivider will comply with the Affirmative Marketing Program as outlined in Document No. 751410, on file in the office of the City Clerk, and in reliance on said assurance does hereby accept the final map of ABERNATHY SQUARE.

The Clerk of said City is hereby directed to transmit said map to the Clerk of the Board of Supervisors of the County of San Diego, California.
